COVID-19 Surge Update for Skilled Nursing Facilities

Dear post-acute and acute care partners,

Thank you for all you are doing to support our community during the current COVID-19 surge! This past Thursday, January 20, San Mateo County Health Officer Scott Morrow joined our monthly Nursing Facility Learning Collaborative call and shared some reflections and guidance on navigating the surge. Please read below for some updates and resources for your staff coming out of that discussion:

During this latest surge, it is critical for post-acute facilities to have red/yellow/green zones operational to enable discharges from hospitals to post-acute. To help your staff with implementing the current admissions and cohorting guidance from AFL 20-87.1, we've published three posters that you can print out for your facility, available online here: www.hpsm.org/provider-covid-resources/content-page-3.

These include:

- 1. An illustration of the current admissions and cohorting guidance for fully vaccinated patients in your facility during seasonal surges.
- 2. An illustration of the current admissions and cohorting guidance for partially or un-vaccinated patients in your facility during seasonal surges.
- 3. A checklist of the criteria for patients to leave isolation (the "red zone"), as well as details and definitions of terms from AFL 20-87.1 and AFL 20-53.6.
