We're excited to share two fantastic CME training opportunities coming up in February and March, that may be of interest to you or your staff:

Medical Care of Vulnerable and Underserved Populations

Dates: Feb. 28th to Mar. 2nd 2019

Location: Holiday Inn Golden Gateway, 1500 Van Ness Avenue, San Francisco CA 94109

How to register:

Cost:

- HPSM Physicians: \$600/course or \$175/day (non-HPSM physicians: \$800)
- HPSM Allied Health Professionals: \$450/course or \$125/day (non-HPSM AHPs: \$700)

In a nutshell: UCSF's Office of Continuing Medical Education is offering a 3-day course on caring for vulnerable and underserved populations. HPSM has received great feedback about past sessions and is offering our network providers a 30% discount on registration. **A pre-course is also available for providers interested in getting their DEA-X certification in order to prescribe MAT (buprenorphine) for opioid use disorders.**

Program detail: After years of documenting disparities in health and health care based on race, ethnicity, gender, education, and socioeconomic status, the medical community has shifted its focus to pursuing health equity. With publicly insured and uninsured patients making up about half of all outpatient visits in the US, and millions of previously uninsured patients continuing to access health care through Medicaid expansions, **becoming an expert in caring for the complicated medical and social needs of vulnerable and underserved patients is crucial to every healthcare provider.**

World-class experts and front-line practitioners from the Zuckerberg San Francisco General Hospital and the UCSF Center for Vulnerable Populations will present approaches to mitigate the challenges in caring for vulnerable populations and enhance the profound joy clinicians can experience when engaging with patients in greatest need. Topics will include updates in a broad range of diseases that disproportionately affect vulnerable patients, such as **HIV, depression, PTSD, obesity, hepatitis and substance use.** In addition, we discuss how clinicians can address social factors that complicate the management of medical illness, such

as **homelessness, school suspension, a history of trauma or of incarceration and food insecurity**. Each day will feature a nationally renowned figure in the field of the care of vulnerable populations.

In a nutshell: The Department of Health Care Services (DHCS) has contracted with the California State University Institute for Palliative Care to provide palliative care training to qualified Medi-Cal providers and their clinician staff.

Program detail: The Institute’s courses are geared toward physicians, physician assistants, nurse practitioners, registered nurses, and social workers interested in building their palliative care skills. Courses are developed by clinical experts in palliative care, and are engaging, interactive, and accessible 24/7. Each course provides continuing education credits or continuing medical education credits.

Please note: Enrollment is first-come, first-served. DHCS will continue to accept applications until all funding has been committed. Providers will be given priority based on geographic and clinical diversity. DHCS will limit funding to no more than four individuals per organization, to support geographic diversity for training.
